General Advice

SECTION 5. FIRE-FIGHTING MEASURES**Suitable Extinguishing Media**

CO₂, dry chemical, dry sand, alcohol-resistant foam. Water mist may be used to cool closed containers.

Contact with water liberates toxic gas.

Specific Hazards Arising from the Chemical

Thermal decomposition can lead to release of irritating gases and vapors. The product causes burns of eyes, skin and mucous membranes. Contact with water liberates toxic gas. Combustible material. Containers may explode when heated.
