## SECTION 4. FIRST AID MEASURES

**Propiolic acid****Eye Contact**

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Immediate medical attention is required.

**Skin Contact**

Wash off immediately with plenty of water for at least 15 minutes. Immediate medical attention is required.

**Inhalation**

Remove to fresh air. If breathing is difficult, give oxygen. Do not use mouth-to-mouth method if victim ingested or inhaled the substance; give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Immediate medical attention is required.

**Ingestion**

Do NOT induce vomiting. Call a physician or poison control center immediately.

**Most important symptoms and effects**

Difficulty in breathing. Causes burns by all exposure routes. . Symptoms of overexposure may be headache, dizziness, tiredness, nausea and vomiting: Ingestion causes severe swelling, severe damage to the delicate tissue and danger of perforation: Product is a corrosive material. Use of gastric lavage or emesis is contraindicated. Possible perforation of stomach or esophagus should be investigated
