**SECTION 5. FIRE-FIGHTING MEASURES****Suitable Extinguishing Media**

Water spray, carbon dioxide (CO<sub>2</sub>), dry chemical, alcohol-resistant foam. Water mist may be used to cool closed containers.

**Specific Hazards Arising from the Chemical**
