SECTION 4. FIRST AID MEASURES**General Advice**

Eye Contact

1-Bromo-3,3,3-trifluoroacetone**Inhalation**

Remove from exposure, lie down. If breathing is difficult, give oxygen. Call a physician immediately.

Ingestion

Most important symptoms and effects
